



## Waiver and Release of Liability for Kahu Pets 808LLC

- I, as the client, declare ownership or authorization in writing from legal owner to enroll the pet listed on Kahu Pets 808 LLC (KP808LLC) New Client form. I assume responsibility for any injuries to the pet while attending KP808LLC. \_\_\_\_\_
- KP808LLC reserves the right to refuse admittance, or dismiss pet at any time if pet does not meet the health, temperament, other requirements of KP808LLC. \_\_\_\_\_
- The client acknowledges that their pet is in good health and up-to-date on vaccines while attending KP808LLC. The client understands that they cannot enroll a pet that may have a condition that could potentially jeopardize the health of other pets or humans. Additionally, the client is aware that even if their pet has received the Bordetella vaccine (Kennel Cough), there is still a chance of contracting Kennel Cough, and they cannot hold KP808LLC responsible for it. \_\_\_\_\_
- If you are planning to board a senior, chronically ill, or a pet with special needs, KP808LLC is a trained and experienced caretaker who can provide the necessary care. However, it is important to keep in mind that special needs pets, puppies, and senior pets are more vulnerable to accidents and stress-related illnesses. Therefore, you should note that by boarding your pet with any of the above-mentioned concerns, you are waiving all claims for injury or illness experienced by your pet unless it is caused by direct negligence or lack of care on the part of KP808LLC. \_\_\_\_\_
- The client agrees to authorize the transportation of their pet to the veterinarian listed on the new client form or to the nearest veterinarian in the event of an emergency. The owner must also authorize KP808LCC to pick up any prescription food, medications, or other products from the veterinarian. The client understands and agrees to bear the cost of any additional expenses that may arise during their pet's stay at KP808LLC. \_\_\_\_\_
- The client acknowledges that if they fail to pick up their pet at the agreed-upon time, they give permission to KP808LLC to take any necessary action for the pet's continued care. The client also agrees to pay an additional fee if the pet remains in care for longer than previously discussed. If the client fails to communicate or pick up their pet within 24 hours of the agreed-upon time, KP808LLC will be authorized to follow the local municipal code HRS A#711-1109.7 regarding the abandonment of animals. \_\_\_\_\_
- The client acknowledges and agrees that neither KP808LLC nor its staff or volunteers are responsible for any illness, injury, death, or escape of the pet, provided that reasonable precautions are taken. The client hereby releases all liability of any kind that may arise as a result of their pet attending or participating at KP808LLC.
- Client understands and agrees that all services by KP808LLC shall be paid up front at time of service. \_\_\_\_\_
